- 1. Called Board Meeting to order at 6:01 PM AZ.
- 2. Adoption of agenda
- a. Cary moved to adopt agenda as written, Jackie seconded. Non-opposed, motion carried.
- 3. Moment of Silence for Sept 11 remembrance.

  - a. Cary moved to approve the meeting minutes as written, Aaron seconded. Non-opposed, motion carried.
- 5. Reports inclusive of updates on projects or tasks not included in agenda below
  - a. Fire Chief: David Newton
    - i. Operations: Two smoke investigations since the July board meeting, one car fire and one tractor fire. Thanks to Animas and Rodeo fire departments for mutual aid in responding to the tractor fire .
    - ii. Training: Trainings have been well-attended
    - iii. Vehicles: All vehicles currently in service.
    - iv. Grants: See 6.c. Grant application review and status.
    - v: Facilities: Thanks to Henry Essary for repairs to one roll-up bay door- bottom most panel to be replaced. Thanks to Chuck Detrick for landscaping maintenance around the station.
  - b. EMS Chief: Alina Downer
    - i. Operations: Five EMS calls since July, EMTs provided patient care on three calls.
    - ii. Training: Trainings have been well-attended. Carolyn organized mass-casualty training that was well-attended by volunteers and community members alike.
    - iii. Vehicles: Both vehicles currently in service, Rescue 4 to have its light bar replaced.
    - iv. Other: Three EMTs recently attended a TMC conference and one EMT attended a trauma conference. The next EMS training will have an outside instructor come in and do special training.

- c. Treasurer: Jackie Lewis

  - ii. 1 CD redeemed today has been deposited into our money market (checking). Vicki from Edward Jones called this morning. We were able to get a 1-year CD with maturation date in September 2026 with 3.75% interest. The best she could get. Interest rates are going down. The CD that matures in December has a 5.2% interest rate. Expectation is that the interest rate will be around 3.25% 3.5% by the end of the month.
  - iii. The Workman's Compensation (WC) audit this year has been interesting and time consuming. Apparently, all of the past providers have not asked for volunteer fire fighter hours, something our new company stated is AZ required. David pulled together an hourly computation spreadsheet for the year. The new calculated premium is incorrect as they did not include \$400 monthly "wages" for all of the other volunteer members. Tammy at Southwest Risk Management is following through with Old Dominion in order to get the corrections made. I do expect a refund for the 2024/2025 year and again next year as we've already paid the higher premium.
